

**APPLICATION FOR MEMBERSHIP AND SERVICE CONTRACT**

**Navarro County Electric Cooperative, Inc.**

**Corsicana, Texas**

The undersigned (hereinafter called the "Applicant") hereby applies for membership in, and agrees to purchase energy from Navarro County Electric Cooperative, Inc. (hereinafter called the "Cooperative"), upon the following terms and conditions:

1. The applicant will pay to the Cooperative the sum of \$ 10.00, which if this application is accepted by the Cooperative, will constitute the Applicant's membership fee. The Applicant expressly agrees that the Cooperative may, prior to the acceptance of this application; use the \$ 10.00 for the development of a rural electrification project. If the Cooperative succeeds in establishing a rural electrification project but is unable to furnish service to the Applicant, the sum of \$ 10.00 will be refunded to the Applicant.
2. The Applicant will, when electric energy becomes available and the meter is installed, purchase from the Cooperative all electric energy used on Applicant's premises and will pay therefore monthly at rates which will be fixed by the Board of Directors of the Cooperative. The Applicant will pay a minimum bill as set forth in the applicable rate schedule for the type of service required by the Applicant regardless of the number of kilowatt hours consumed.
3. The Applicant will cause his premises to be wired in accordance with wiring specifications approved in the National Electric Code and the Cooperative shall have no responsibility relating to the Applicant's wiring at or on the Applicant's premises.
4. The Applicant will comply with and be bound by the provisions of the charter, by-laws, and tariffs of the Cooperative, of which Applicant will be a member, and such rules and regulations as may, from time to time, be adopted by the Cooperative.
5. The Applicant hereby grants to the Cooperative, the right and easement to construct, operate, repair, rebuild, and maintain on all premises owned by the Applicant and served by the Cooperative, and in or upon all streets, roads, or highways abutting Applicant's premises, its electric distribution and service lines and appliances, and also the right to cut or trim trees as deemed necessary by the Cooperative, to keep them clear of all parts of the electric system. The Cooperative shall have the right to clear the right of way of all obstructions. The Cooperative is specifically granted the right of pedestrian and vehicular ingress and egress in order to perform all functions required as well as connecting, disconnecting, and reading of meters.
6. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative. At such time as the electric meter is energized at Applicant's premises this completed document shall be considered the Applicant's Certificate of Membership in the Cooperative.
